

# STEP 12: An Act of Bravery

As a general rule, people are scared to death of the disapproval of "authority." Stanley Milgram's experiments proved this to a truly disturbing degree, by showing that most people are willing to inflict severe pain, or even death, on their fellow man just because an "authority" figure told them to. No, I'm not talking about Nazi Germany; I'm talking about the good old U.S.A.

The point is, most people are so utterly terrified of going against what "authority" wants, that they will allow some pretty nasty stuff to be done (to themselves and others) before doing anything about it. Nonetheless, I am here to **DARE** you to commit an act of **REBELLION**. No need to go for the pitchforks, or to kiss your loved ones goodbye. This particular act of rebellion isn't dangerous, or controversial, nor is it physically difficult. But many still wouldn't dare to do it.

I want you to send a letter to a Congressman or a Senator, with a copy to the Commissioner of the IRS, in order to politely **ASK QUESTIONS** about how you are to determine what taxes you owe (if any). That's it. You don't need to argue anything, or know the correct answers to the questions. Heck, you don't even need to fully **UNDERSTAND** the questions, though I hope at this point most of you do.

These are questions which are based on what the government's own law books say, which your CPA or tax attorney most likely **CANNOT** answer, but which you **MUST** have answers to if you are to determine what you owe. Remember, the IRS "Mission Statement" includes helping you "**UNDERSTAND**" your tax responsibilities. So let them.

The reason we use a system of **WRITTEN** law in this country is so that the law will be **KNOWABLE**. In other words, the law itself **MUST TELL YOU** what is

required of you. With that in mind, how bizarre is it to have 100,000 people in government trying to enforce a law and **demanding** that 100,000,000+ people comply with it, if they can't say **HOW** to comply with it? (As an analogy, imagine if your local government sent you a property tax bill without any **NUMBERS** on it, and when you asked how to determine what you owe, they responded with "That's frivolous! Now pay up or else!")

Is the "authority"-fear quirk kicking in yet? Have you already thought of a reason why you don't have time to print out a letter, put your name on it, and mail it? You don't want to get involved? You don't have time? You don't want to draw attention to yourself? You don't want anyone to think you're wacky, or a trouble-maker?

There are lots of excuses, but when you consider the situation, none of them hold water. Repeat after me: "I don't know how to determine what I owe, but I also don't dare to ask the government." Not the kind of thing that can be said with head held high in the "land of the free," huh? So stir up a little of that good old-fashioned rebellious American spirit, and **SEND A LETTER**.

Here is how to do it:

- 1) First, find the letter itself at the link below, and "cut and paste" the whole thing into any word processor or text program (or right click on the at the top and save the letter in either **Word** or **WordPerfect**) found at:

- 2) Look up your congressman's or senator's mailing address at these links:  
Find your congressmen (by zip code): <http://www.house.gov>  
Find your senators (by state): <http://www.senate.gov>
- 3) Fix the date on the letter, and right below it put in the name and address of the congressman or senator.
- 4) Enter your name and address at the bottom of the letter. (If you think the "P.S." at the bottom of the letter is too strong, feel free to take it out.)
- 5) Be sure to send **BOTH** pages (cover letter and questions page). Sending it certified mail is a big plus (you have proof they received it).
- 6) Be sure to print an extra copy to send to Mark Everson, IRS Commissioner, whose address is included at the bottom of the letter.
- 7) Once the letter is sent, please let me know ([larken@taxableincome.net](mailto:larken@taxableincome.net)) which congressman or senator you sent it to you, and what DATE it was sent. And **PLEASE** let me know as soon as possible if you receive any response to your letter.

Again, this is nothing more than **ASKING** those in government to explain how their **OWN** laws apply, which they have a responsibility to do. This is not a "protest," nor does it require you to "argue" anything. You're only asking that those in government tell you **THEIR OWN POSITION** on how you should determine what you owe. If they are unable or unwilling to do that, **THEY** (not you) should be embarrassed by the questions.
